### **General Purpose Cord Reel Lights**

Conveniently mounts on wall or ceiling to handle all light-tomedium-duty incandescent task lighting needs. Cord locks at desired working length, and retracts with a slight tug. Sturdy steel housing, 2-ft. installation cord. Lamp not included. No. 2V563 rough service lamp (75W) is recommended.

### **CORD REEL LIGHTS**

Comfortable handle has convenient tool tap outlet and dependable push-button switch. UL Listed. Nos. 1A135 and 6X756 have grounded handles with a 7amp resettable circuit breaker, and are CSA Certified No. 1W943 is also CSA Certified.

#### CORD REEL WITH **MAGNETIC LIGHTS**

Powerful magnetic swivel base on light attaches to any nearby ferrous metal surface—brings light close to where you need it. Easy to aim for hands-free use.

#### SPECIAL PURPOSE **REEL LIGHT**

### 3-OUTLET

Pulls out and locks at desired working length; automatically retracts with a slight pull of cord. 3 grounded female outlets on a molded tap. 9½" dia. steel housing swivel mounts on wall or ceiling. Complete hardware included. Has a 2-ft. installation cord. 125V. CSA Certified.

#### 4-OUTLET

Features a carrying handle, circuit breaker protection, and 4 grounded female outlets. 125V, 60 Hz
